Executive Report

A micalola EMC's financial position remains strong, and rates remain low and stable. There has been no rate increase for the past 15 years. We did add a temporary power cost adjustment (PCA) during a few months of 2022, due to the sharp increase of market prices of fuels used to generate electricity, but have since removed the PCA. Even with the addition of the PCA, our members continued to pay less for electricity than the local investor-owned utility and the state average.

In January 2022, the cooperative rang the new year in with a jolt as high winds swept through our service area the morning of Jan. 3, leaving a tangled mess of trees and power lines. The National Weather Service reported wind gusts up to 39 mph, but one Dahlonega member reported their home weather station registered gusts of 73 mph at one point. As a result, approximately 14,400 members were without power and at least 50 broken poles had to be replaced. Widespread damage occurred in all 10 counties of our service area; all power was restored by Wednesday, Jan. 5, around 9:30 p.m.

There is widespread growth across our service area, primarily residential growth. By the end of 2022, we had reached a membership of 54,331 members spread across 5,921 miles of line.

We continue to see a slow progression of our long-time employees reaching retirement age, as 12 employees of the cooperative retired during 2022. These 12 employees collectively dedicated 456 years of service to the members of Amicalola EMC, with the average length of service being 38 years. In turn, headquarters saw the announcement of a newly promoted vice president of Operations and Engineering, and newly promoted operations managers were named at both district offices. All three are highly qualified, dedicated employees, and each has over 20 years of on-the-job experience with our cooperative.

In August, we introduced a new member service portal through Meridian, a provider of leading-edge software and technology solutions to utility providers across the

country. This portal allows members easy and secure access to review energy use, check the balance on their account or pay their bill.

In 2022, we installed two ChargePoint Level 2 EV charging stations in Pickens County. Located at Piedmont Mountainside Hospital in Jasper and the Foothills Shopping Center in Marble Hill, both are capable of charging 10-20 miles of range per hour of vehicle charge time.

Our board of directors once again authorized a capital credits refund, returning a \$2.6 million general refund to members who had service during 2002.

In accordance with Georgia's unclaimed property laws, unclaimed capital credits totaling \$400,000 were awarded locally for education, economic development projects and local nonprofits, which included \$140,000 in college scholarships for high school students, \$50,000 in Bright Ideas teacher grants, \$47,000 to local fire departments and donations to various other qualifying projects and organizations.

Directors Kathy Burt (Post #7, Dawson/ Forsyth counties) and Edward Tucker (Post #9, Lumpkin County) were re-elected for three-year terms at the 81st Annual Meeting in October. Director Shelley P. Cantrell (Post #4, Pickens/Gordon counties) was also elected for a three-year term.

Plans are now underway for the 2023 Annual Meeting of the Membership to be held on Saturday, Oct. 7. Registration for the meeting will begin at 11:30 a.m. Entertainment will be from 12:30 p.m. to 1:30 p.m., and the business meeting will begin shortly thereafter. Please make plans to attend.

ANNUAL MEETING MINUTES October 8, 2022

CALL TO ORDER—Chairman Charles R. Fendley, having determined from the registration clerks that a quorum was present, called the 81st Annual Meeting of Members of Amicalola Electric Membership Corporation to order on October 8, 2022. The meeting was held at the headquarters facility in Jasper, Georgia.

INVOCATION—John Bennett gave the invocation.

WELCOME—Chairman Fendley welcomed members and visitors on behalf of the Board of Directors.

BUSINESS SESSION—Attorney Phil M. Landrum, III, conducted the meeting.

NOTICE OF MEETING—Attorney Landrum read the meeting notice and proof of mailing of the notice of the 2022 Annual Meeting.

MINUTES AND FINANCIAL REPORT—Attorney Landrum stated that the reading of the minutes of the 2021 Annual Meeting would be dispensed with unless called for since copies of the minutes and the Financial Report of the Cooperative as of the December 31, 2021 Audit had been forwarded to members as part of the official notice of the meeting. As there was no call for reading of the minutes, a motion was made, seconded, and carried that the minutes be approved as submitted. Accordingly, Attorney Landrum announced that the minutes of the 2021 Annual Meeting were approved as mailed.

UNFINISHED BUSINESS—There was no unfinished business.

NEW BUSINESS—There was no new business.

NOMINATING COMMITTEE REPORT—Attorney Landrum recognized the Nominating Committee members who were present, and then read the report of the committee placing in nomination the following to serve as directors for three-year terms ending at the Annual Meeting 2025: James Bryan, Post 4, Pickens County and Gordon County; Kathy Burt, Post 7, Dawson County and Forsyth County; Edward Tucker, Post 9, Lumpkin County. There was one nomination by petition. Shelly Cantrell qualified for Post 4, Pickens County and Gordon County.





SPECIAL SERVICES



PRIZES


At the time of registration, each voting member will be given a voting member identification sticker and prize stub.



Vick, Billy Edmondson, Larry Fann and Clayton Vaughters. The Election Tellers collected the ballots. While the ballots were being counted, the meeting continued.

CHAIRMAN'S REPORT—Chairman Fendley reported that on September 1, 2022, capital credits totaling over \$2.6 million were refunded to members with accounts in 2002. After several years of diligently searching, unclaimed refunds are used to support many organizations throughout our service area, including college scholarships, Bright Ideas teacher grants and donations to local nonprofits and economic development projects. Chairman Fendley added that the cooperative remains financially strong, with rates remaining stable. He concluded by encouraging members to exercise their right to vote in the upcoming general election.

CEO'S REPORT—CEO Payne welcomed everyone to the 81st Annual Meeting of Members of Amicalola EMC. He discussed the growth of the cooperative as 53,898 meters have been connected over 5,888 miles of line. It's still been a busy and productive time for Amicalola EMC, even with the supply chain issues. The partnership with ETC, which has added fiber to the internal communication network and has also expanded broadband service throughout our rural service area, continues. CEO Payne gave an update on the distribution automation system that is being installed. This project so far has saved members over 7 million outage minutes. CEO Payne also discussed a new substation in Gilmer County, system upgrade projects that are taking place across our service area, and the LED outdoor light project. The cooperative has also been involved with new solar projects and has recently installed two electric vehicle charging stations in our area. AEMC will continue to focus on providing reliable electricity to our members at an affordable price.

RECOGNITION OF GUESTS—Chairman Fendley recognized all veterans who were present. Operation Round Up Trustees, retired employees and retired board members were also recognized. Kathy Fellows was acknowledged for taking blood pressures for those in attendance. The following guests also attended: Amy Schneider, GEMC's *Georgia Magazine* and Lloyd Snyder, Oglethorpe Power Corporation.

PRESENTATION OF AWARDS—Chairman Fendley announced the names of service award recipients for 5, 10, 15 and 25 years of service. Stacey Fields, Tim Cline, Randy Mooney, Scotty Newberry, Dwight Henderson, David Mullins, Ray Carpenter, Gary Chester, and Marty Dean were recognized for 35 years of service. Donna Gaddis and Luther Walker were recognized for 40 years of service. Director Charles Fendley was recognized for 50 years of service.

RESULTS OF ELECTION—Attorney Landrum gave the report of the election prepared by the Election/Credentials Committee. For Post 4, Pickens/Gordon counties, Shelley Cantrell received 111 votes and James Bryan received 92 votes. Shelley Cantrell, Post 4, Kathy Burt, Post 7, and Edward Tucker, Post 9, will hold office until the 2025 Annual Meeting of Members, or until their successors have been elected and qualified.

DISTRIBUTION OF PRIZES—Ethan Carlan drew the tickets for prizes provided by Amicalola EMC.

Being no further business, Chairman Fendley adjourned the meeting.
