# **Preparing for the future**

micalola EMC will soon begin construction on a new district office in Dahlonega. Members in Dawson and Lumpkin counties will be served by the office, which will be constructed at the intersection of Hwy 52 and Hwy 9.

The current location on Hwy 9 has served members in this area since 1982, but to maintain reliability and to prepare for future growth, it's necessary to have adequate room to store equipment and materials.

Amicalola EMC has grown substantially in the 35 years since the office in Dahlonega was opened.

In 1982, there were 2,301 miles of line which

served 13,563 meters. There were 76 fulltime employees. One cashier and a four-man service crew worked out of that location.

Today, there are 5,596 miles of line that serve more than 48,000 meters. There are 135 full-time employees. That office

is home to a district manager, three member service representatives, one warehouse person and two construction crews. Construction should begin

by mid- to late summer and an open house is planned once

the facility is complete.

Members visiting the Jasper headquarters office this summer will also notice some construction taking place. The administration building, which was originally constructed in 1984, will be getting a new roof, some needed repairs, an updated front exterior and additional employee parking. Normal business hours can be expected during the construction, and your patience is appreciated as the work is being done.

I'd also like to announce the recent promotion of Todd Satterfield to District Manager of the headquarters office in Jasper. Satterfield began his employment with Amicalola EMC in 1983 and will bring 34 years of experience and knowledge to his new position. He has held various positions on the line crews and has been a service crew leader since 2006. His new duties will include supervision and scheduling of the line construction crews working out of the Jasper office.




